

Terms and Conditions:

- 1. The promotion period is from 9 September to 13 October 2024 (both days inclusive, the "Promotion Period").
- 2. During the entire promotion period, My FESTIVAL members (the "Members") who use the designated electronic payment method to spend HK\$2000 or above in a single transaction from a designated merchant (the "Eligible Tenants") and upload the original transaction receipt and the corresponding transaction proof (the "Eligible Transaction Documents") to the My FESTIVAL Loyalty Programme via Festival Walk mobile app within 7 days of purchase to earn a HK\$100 shopping e-Coupon (the "Reward").
